### How to benefit from tax concessions?

The PSL Foundation is a **foundation of scientific cooperation**. It is subject to the rules governing to foundations recognised as being of public utility. Only residents in France can benefit from tax concessions<sup>2</sup> :

- **75%** of your donation to the PSL Foundation is deductible from your **tax on real estate – impôt sur la fortune immobilière (IFI)**, up to a maximum deduction of €50,000;
- **66%** of your donation to the PSL Foundation is deductible from your **income tax – impôt sur le revenu (IR)**, up to 20% of your taxable income;
- **60%** of your donation to the PSL Foundation is deductible from your **corporate tax – impôt sur les sociétés (IS)** if you decide to act through your company (within the limit of the highest of the amounts between a ceiling of €10,000 and 0.5% of the turnover, which can be spread over 5 years).

The PSL Foundation, located at 60 rue Mazarine 75006 Paris, processes the information collected in the context of this form, in its capacity as data controller. This data is recorded in an automated file by the subcontractor Salesforce.

The data controller guarantees compliance with the Data Protection Act No. 78-17 of January 6, 1978, as amended by the General Data Protection Regulation No. 2016/679 of the European Parliament and of the Council of April 27, 2016 (RGPD), both by itself and by its subcontractor.

The data is collected for the following purposes: sending tax receipts to donors, management of donations transferred, donor gratification. The legal basis for this processing is the legal obligation: in accordance with Law No. 2021-1109 of August 24, 2021 reinforcing the respect of the principles of the Republic, in terms of donations, the PSL Foundation must issue tax receipts in order to preserve evidence of donations received in the event of an audit by the tax authorities. The data collected is communicated exclusively to the Development Department. If you have given your consent, your data will be transmitted to the component institutions of PSL University. The data collected is kept for a period of ten (10) years from the date of collection. At the end of this period, it will be deleted.

On the legal basis of its legitimate interest, the PSL Foundation is authorized to contact you again for the sole purpose of carrying out non-commercial prospecting for future fundraising campaigns organized by it. You may be opposed to this by checking the box above. It may transfer your data to other component institutions of PSL University for the purpose of non-commercial prospecting, unless you object.

The PSL Foundation has implemented the technical and organizational measures necessary to ensure the security of your data. In accordance with the RGPD, you have a right of access, rectification, deletion, portability, limitation of processing and a right to oppose the processing of your data.
